



## Terms and Conditions

Welcome to **Nature Fix Photography** ("Company," "we," "our," or "us"). By accessing or using our website (the "Site") and related services, including booking photography sessions and purchasing images (the "Services"), you agree to be bound by these Terms and Conditions. If you do not agree, please do not use our Site or Services.

### 1. Intellectual Property

All photographs, images, text, logos, and other content on this Site are the intellectual property of Nature Fix Photography and are protected by copyright laws. You may not copy, reproduce, distribute, or use any content without prior written permission.

### 2. Purchases & Payments

- All session bookings require a **non-refundable deposit of fifty percent (50%)** of the total session fee to confirm the date and time.
- The deposit must be paid within forty-eight (48) hours of booking confirmation. If the deposit is not received within this timeframe, the booking will be canceled.
- The **remaining balance** must be paid in full no later than twenty-four (24) hours before the scheduled session. Failure to pay the remaining balance by this deadline will result in cancellation of the session and forfeiture of the deposit.
- Prices are listed in U.S. dollars.
- For digital products, once files have been delivered, all sales are final.
- All photographs included in a session package will be delivered to a **private online gallery** within **ten (10) days** of the session.

### 3. Bookings & Services

- Bookings are considered **tentatively confirmed** when scheduled. A **non-refundable deposit of fifty percent (50%)** of the total session fee is required within forty-eight (48) hours of confirmation to secure the date and time.
- If the deposit is not received within forty-eight (48) hours, the booking will be canceled and the date released.
- The deposit will be applied to the total session cost.
- The **remaining balance** must be paid in full no later than twenty-four (24) hours before the scheduled session start time. Failure to pay the remaining balance by this deadline will result in cancellation of the session and forfeiture of the deposit.
- Clients who provide at least **seventy-two (72) hours' notice** may reschedule once, and the deposit will be applied to the rescheduled session.
- Sessions proceed as scheduled, regardless of weather.

### 4. User Obligations

You agree to use our Site and Services only for lawful purposes. You are responsible for ensuring that all information you provide is accurate and up to date.

### 5. Limitation of Liability

Nature Fix Photography is not liable for any indirect, incidental, or consequential damages arising from the use of our Site or Services. We make no guarantees regarding uninterrupted access or error-free performance of the Site.
